Setting Up Your Account

Your free, personal account will let you connect and share to your social media profiles and connect to Midland National and other professionals on Gainfully. You'll need a web browser on a desktop, laptop, or tablet computer and your LinkedIn account log in information.

Step 1: Create your account

Visit https://gainful.ly/signup/midland-national/261/#/

Go to the signup link in your browser and click the Log In with LinkedIn button. If LinkedIn prompts you to sign in, use your personal LinkedIn username and password. You will then confirm your basic profile information and create a Gainfully password.

Step 2: Confirm compliance profile

Once inside Gainfully, go to <u>your account profile</u> and confirm any FINRA or SEC registration affiliations. This will apply any additional compliance policies to your account needed to use Gainfully safely.

Step 3: Build your library

Visit https://gainful.ly/dashboard/#/Midland-National/organization/261/feed

Go to the Midland National page to discover content and campaigns you can add to your personal library. From <u>your profile page</u> you can choose times to have your library content shared automatically, everyday.

Step 4: Set-and-forget your sharing

Once your library has some content cards in it, you can optionally turn on Autosharing. Autosharing enables you to have content automatically selected and shared from your library multiple times per day. We highly recommend it (you'll see what we mean)!



Compliance

Tip: Consult your compliance officer if in doubt about any setting or content item

The Midland National compliance policy governs which social media or other publishing profiles Midland National affiliates can utilize in Gainfully. For outside customers, their policy will be based on their own affiliation with supervising organizations, such as a broker-dealer.
